The Government has also approved work permit for yourself. Please note that the work permit will be issued upon payment of F\$385 and F\$1800 as immigration fee and bond respectively.

The above approval and assistance have been granted subject to the following conditions:

- A. The company shall in the course of implementation and operations give preference to utilizing supplies, including materials, consumables, services and investment objects of local origin whenever available in acceptable qualities to reasonable prices.
- B. Within a period of six months from the date of approval the company must submit to Fiji Trade and Investment Board an implementation schedule and evidence that it is engaged in implementation of the project.
- C. Commercial operations must start within 12 months from date of project approval unless a prolonged implementation schedule has been accepted at an earlier stage. The date of starting operations must be confirmed to FTIB without delay.
- D. Audited annual accounts and other information as may be required must be forwarded to FTIB without delay.
- E. Approval and assistance will automatically be withdrawn if any of the above conditions are violated.
- F. Approval has been granted based on the information you submitted. If the information is incorrect or if the situation changes substantially, FTIB reserves its right to review the approval granted.

With regard to the issue of shares to non-residents, please apply to the Reserve Bank of Fiji.

- Support of PC users (inc. newsletter and user group)


